Students are informed that the **ATKT Examinations (NEP & CBSGS)** for **Sem I / II / III & IV** will be held in the month of **October 2026**. The dates for filling up the ATKT Examination Form – Winter 2026 have been extended.

Students who wish to appear for ATKT Examination must register as follows:

I. **Filling up of the College ATKT Application Form**

Fill the Online Examination Form on the link: <https://cimsstudent.mastersofterp.in/>

This link will be active between **Saturday 5th September 2026 to Saturday 12th September 2026**

Steps for Filling up the ATKT Application Form

1. Login into <https://cimsstudent.mastersofterp.in/>
2. Goto Examination -> Apply for ATKT Exam Subject
3. Select Course & Select Session
4. Select (Check mark) **All Subjects** as shown in the list
5. Click on Calculate Amount
6. Click on Apply for Subject

Note: Select all subjects for which you wish to apply at Once. You cannot add / delete / modify the subjects after Apply.

7. Goto Payable Fees and pay the due amount.

Note: ATKT registration will be considered only after payment of fees.

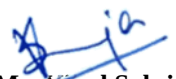
After filling up of the form, the students must submit a print out of the same to the Examination Section between 11:00 am – 1:00 pm

Please Note:

1. No forms will be accepted after the above-mentioned schedule on any ground whatsoever
2. If any discrepancy is found in the Examination Form, it will be considered invalid.
3. If the student fails to fill up the University Form as mentioned in Step III, the result for such students shall not be processed.
4. Students with Unfair Means, have to fill the ATKT forms as per the verdict given. If any student is not eligible to appear in October November 2026 and fills the ATKT Examination form, will not be allowed to appear for the Examination. In case of any doubt, students may contact Mr. Vipul Saluja, Vice Principal along with a copy of the Unfair Means verdict.
5. This is the last extension and further extension shall be given. No forms will be accepted after 13th September 2026 on any ground whatsoever.
