Competitiveness Mindset Institute (CMI), USA, a non-profit institute is engaged in research and education in competitiveness skills. CMI has developed educational programs for youth at different levels/grades in education and for working professionals, to learn to recognize, develop, practice and inculcate the Big Five non-cognitive (soft) skills related to competitiveness identified through a nationwide survey by CMI in collaboration with IIT Gandhinagar.

1. What does the FLY-Scholar program do:

- Helps amplify the hard skills the PIs teach them throughout their degree course &
- Help them acquire competitiveness mindset & improve their employability.

2. What does the FLY-Scholar program consist of:

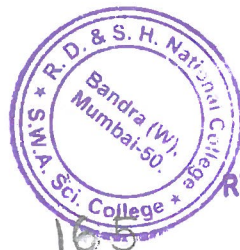
The structure of the FLY program is based on the CMI's instructional framework *LIFE©*. *It consists of Learning, Introspection, Fellowship and Engagement.* Details in Annexure 1. Students enrolled for this program are required to participate in all the above four components.

3. What CMI provides:

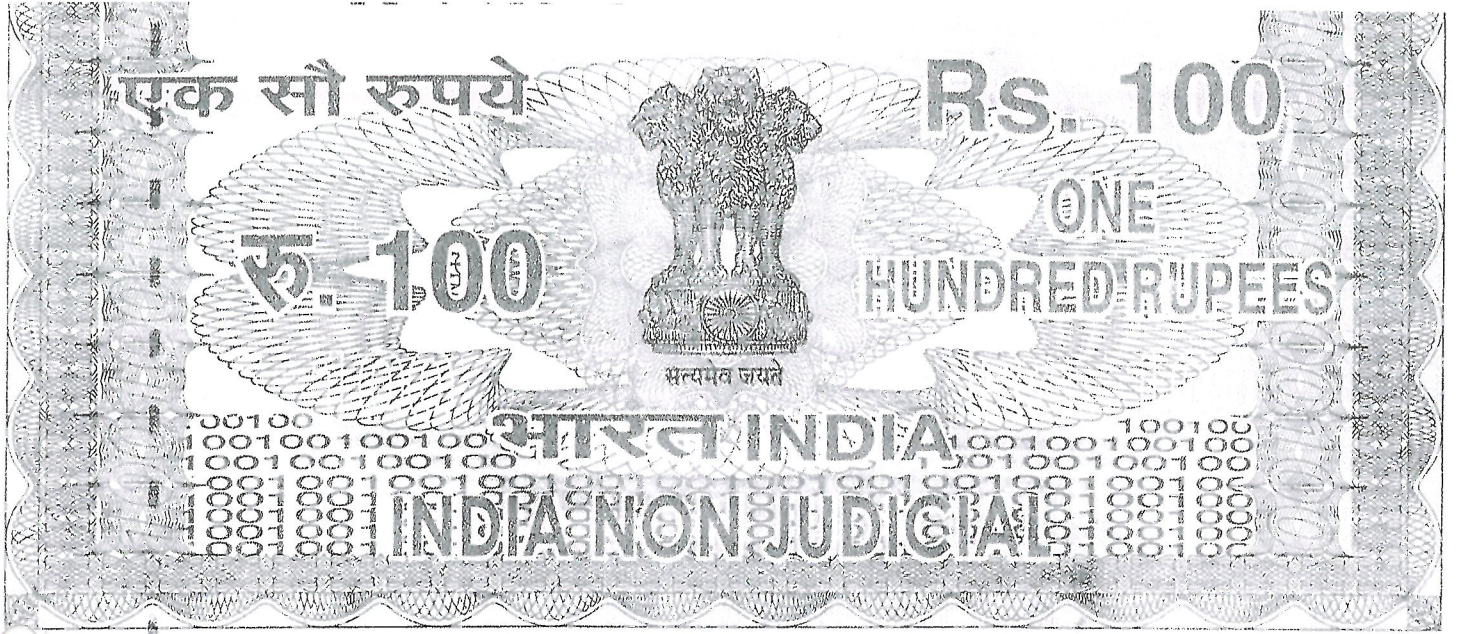
- CMI Facilitators (Master Trainers) will conduct the program either Online using interactive distance learning platforms, or face to face which will be entirely at PI facilities.
- The class schedule will be mutually arranged between the PI and CMI, Mumbai.

4. What the Participating Institution will provide (at no charge to CMI, Mumbai):

- Scheduling of the program with all its components will be worked out in consultation with the PI, who shall ensure, taking into account other commitments of enrolled students, that students are able to fully participate in all four components of the program. Suggested schedule plan is to be finalized.
- Classroom(s) to hold up to 36 students each, and the On-line programs will be restricted to 24 students. Students registration details to be provided to CMI as specified.

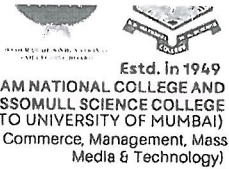

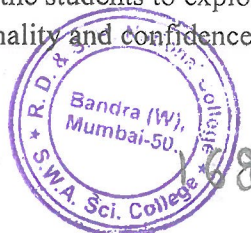
I. Background
